Dear Chaverim,

In accordance with the decisions of the I.M.C. regarding minimum participation, a set of recommendations have been drawn up to be discussed at the next meeting of the I.M.C.

- 1. Minimum number in each event shall be according to the attached table.
- 2. In case of insufficient numbers of teams in the team event, it has been recommended to allow two Israeli teams to participate or to run the event with three teams and two round-robins.
- In Wrestling and Weightlifiting it is recommended to allow participation of three athletes from each country in each weight category.
- 4. In Track & Field it is recommended to allow participation of four Israeli athletes in case of insufficient numbers of athletes from abroad.
- 5. It is recommended that in the event of only three teams taking part in sports events, only the first prize will be distributed.
- 6. It is recommended that if in the individual events only three athletes from different countries participate, only the first prize will be distributed.

The Chairman of the Organising Committee and the Deputy Chairman will again be Michael Kevehazi and Arie Rosensweig respectively.

Please inform us as soon as possible the name of the responsible person in each country to whom Maccabiah correspondence should be sent. In turn you should send Maccabiah correspondence to us as follows:

- matters concerning the functioning of the IMC the the Chairman of the IMC.
- matters concerning the preparations for the Maccabiah the Chairman of the 12th Maccabiah Organising Committee.

In particular we would like to receive regular information on progress of your organisation, outstanding sports achievements, press cuttings and photographs, etc.

We are planning to send out a first preliminary questionnaire on possible participation in September this year. Other planning material and proposals will be circulated by December, in preparation for the February 1983 meeting of the IMC.

Please note that our circulars will be numbered. We ask you to file this letter for reference as we shall refer back to previous circulars from time to time. If you will note from a serial number that a previous circular has not been received, please let us know urgently.

Session 1 - April 22, 1982

Dr. Peled opened the meetings and welcomed the delegates. He stated that the lith Maccabiah was a great success in all ways and by starting three years before the 12th Maccabiah, we can hope to be successful again and correct the mistakes made.

Michael Kevehazi presented the Report of the Conclusions Committee, explaining the extensive and detailed work which was carried out at all levels in order to collate these conclusions based on hundreds of reports from Israel and abroad. He mentioned with regret, that some countries did not send reports.

RESOLVED APPOINTMENTS:

- 1. THE IMGC notes that Dr. Israel Peled, as Chairmen of the MWU is the Chairman of the IMGC.
- 2. The following appointments were approved by acclamation:

Yitzhak Caspy - IMGC Vice-President Joel Haskel - IMGC Vice-Chairman Alberto Plotnik - IMGC Vice-Chairman Haim Wein - Hon, Chairman Organising Committee.

3. The position of President of the IMGC to be filled at a later date.

The organisational structure of the IMGC was discussed.

RESOLVED:

- 1. Any requests for additional places are a matter which under the IMGC Constitution can only be decided on by the MNU Executive.
- 2. Alternate members be appointed specifically to a particular meeting of the IMGC as replacement for a member who cannot attend. He will have no other rights in his personal capacity. Countries are welcome to bring additional people as observers to the meetings.
- 3. IMGC members should be involved in specific active tasks in the Maccabiah.

Framework of sports events.

RESOLVED:

- 4. At this stage no sports should be deleted from the programme.
- 5. The following additional items to be included in the preliminary questionnaire to be sent to countries for the purpose of ascertaining possible participation:

ARCHERY: RUGBY: ORIENTEERING: BOXING: DIVING: BODY BUILDING: CYCLING.

The inclusion in this list is for the purpose of gathering information only. A decision for inclusion to be taken by the next IMGC meeting.

6. The USA to be requested to investigate the holding of a tournament for top Jewish professional tennis or golf players during the Maccabiah and other means of involving Jewish top athletes who cannot compete in the Maccabiah.

- 7. The date for receipt of Entry Form 2 is January 15, 1985. The IMGC meeting to be held soon thereafter shall decide on cancellations.
- 8. The Organising Committee to send out by December 31, 1982 suggestions for any changes in minimum participation requirements. These suggestions shall be on a sport by sport and event by event basis, bearing in mind the particular requirements of each sport. Special consideration may be suggested for women's events. The possibility of more than one competitor per country in certain events to be considered, as well as the entry of 2 Israeli teams in certain team events.
- 9. The minimum participation rules may be changed after Entry Form 2, if necessary to avoid cancelling an event which had previously been agreed to be held, so as to avoid last minute disappointment to other competitors. Such suspension of the 'minimum' rules shall only be made by a small special committee of the IMGC.

Session 2, Chairman Joel Haskel

Before the resumption of the Agenda, the meeting requested an explanation of the newspaper reports relating to the U.S. Committee and the IMGC.

Michael Kevehazi explained the facts,

Leonard Reifman (USA) said: "we don't think this is funny. We have been cursed, we have been blackmailed. We came to join our colleagues, we are a non-political organisation and have been accued of not telling the truth and don't believe our motives. We would just like everyone in this room and in Israel to know that these are not our motives. We would like you to let everyone know that our aims are to further the Maccabi Movement and not to get into political battles with anyone".

Michael Kevehazi answered: "I wish to repeat the sentiments expressed by Dr. Peled the previous day." "We are full of regret for what has happened. Not only because we do not like people whose motives we do trust to be put into this sort of position, but, we apologise as Israelis. We feel that from Israel an injustice has been done which we tried to avoid. We will work through the Israeli sports organisations in order that this injustice will be righted. We hope that this storm in a teacup will be forgotten in a few weeks. We should demonstrate by the work of the IMGC that this is what we are here for and not for talking politics." "Regarding the allegations in the press that Elitzur and Betar are supporting the attack on the U.S. Committee and are also not participating in the IMGC meetings, their presence here with us clearly refutes these mis-statements."

After considerable discussion and exchange of views, the following amendment and resolution were voted upon and carried with a large majority:

RESOLVED: ETERAN EVENTS:

10. All Veteran events to be held during the period of the Maccabiah as separate competitions which are not part of the official Maccabiah. They will be held at separate venues both as far as competitions and training are concerned. The requirement for a separate venue does not apply to GOLF.

Competitors will not live with the regular team and the organisation will be separated from the Maccabiah Organising Department. There must be sufficient distinction in uniform to be able to identify the Veterans.

Particigation in the Veteran Events is subject to approval of the Maccabiah Organising Committee of that country.

However, the Veterans will be permitted to march in the Opening and Closing Ceremonies.

Session 3. Chairman Robert Spivak

RESOLVED INTERNATIONAL REFEREES

The Conclusions Committee recommendations approved.

ACCOMMODATION (including Food, Airport, Registration procedures & Merical):

Information was given about the possibility of a further 300 beds being built at Kfar Hamaccabiah and 150 beds at Wingate.

RESOLVED:

- 11. To continue the system of accommodation by sports,
- 12. To discontinue use of the old dormitories at Wingate.
- 13, To recommend that team captains stay at Kfar Hamaccabiah.
- 14. All other accommodation centers to be discussed at next meeting only, after receiving proposals from the Organising Committee.
- 15. The Finance Department to be given suitable rooms to enable proper discussions with team managers.
- 16. The recommendations of the Conclusions Committee approved.

RESOLVED TRANSPORT:

- 17. An efficient shuttle service is essential.
- 18. The other Conclusions Committee recommendations approved.

FINANCE

The Financial Report, showing a breakeven, at a total cost of \$3 m. was presented for information.

RESOLVED:

- 19. The Conclusions Committee recommendations approved, with the correction that item 3 (3) on page 25 should refer to the IMGC and not the Maccabiah Headquarters.
- 20. The Organising Committee will be authorised to make a non-refundable registration fee in order to avoid irresponsible preliminary entries. If a country is for some reason allowed a late registration, an increased registration fee to be paid.

RESOLVED YOUTH KENESS:

21. The Youth Keness should not be held. The MWU will encourage the visit of youth groups to Israel during the Maccabiah.

RESOLVED JUNIOR MACCABIAH

22. A Junior Maccabiah to be held at the same time as the Maccabiah.

A discussion developed on the character and scope of such Junior Maccabiah. A sub-committee chaired by Roy Salomon (Canada) with Daniel Arayou, Wilfred Lissack, Alan Sherman, Wolfgang Wronkow and Arie Rosensweig, was requested to prepare proposals for presentation the following day.

RESOLVED TICKETS:

23. The Conclusions Committee report approved.

RESOLVED V.I.P.'s:

- 24. The Conclusions Committee report approved.
- 25. Further efforts to be made to avoid duplication in social events and receptions.
- 26. A special afternoon to be selected as suitable for Embassy Receptions for complete teams.
- 27. To provide further facilities for opportunities for informal get-togethers of team leaders and managers.

Session 4. Chairman Alberto Plotnik

RESOLVED ADVERTISING, PUBLICITY, LOGO:

- 28. The Organising Committee is authorised to negotiate with graphic artists for the design of a new logo. After receiving proposals, the Organising Committee may also decide on using a previous logo, although a new one is preferable. The decision to be arrived at, if possible, within three months.
- 29. The "Guri" to be used again, with possible up-dating.
- 30. The Conclusions Committee recommendations approved.

PRESS, RADIO & TELEVISION

The discussion emphasised the importance of proper handling of the foreign press and media.

RESOLVED:

- 31. To ask the U.S. Committee to investigate the possibilities of negotiating Television coverage and rights for the USA or also world-wide.

Session 5. Chairman Wilfred Lissack

- 37. The Organing Committee to try and prepare for Hotels for Tourists Groups and Car Hire on a centrally negotiated basis and countries are asked not to close deals before receiving this offer.

RESOLVED CULTURAL & ZIONIST ACTIVITIES, TOURS, ETC.

- 38. The recommendations of the Conclusions Committee approved.
- 39. To hold an International Quiz. It it is held all participants from abroad should receive certificates.
- 40. Tree planting to be held only if it can be carried out physically or find similar programmes involving personal participation.
- 41. Tours should not be charged for. Teams to be encouraged to make participation in tours compulsory. More tours to be on basis of participation in meetings with Israel youth, e.g. sports meets with kibbutzim or Army teams.

RESOLVED ALIYAH DESKS:

42. To continue to have desks at all accommodation centers.

RESOLVED BLOOD DONORS

43. To continue with this but with better publicity and timing. The scheme should be planned for the days after competitions.

RESOLVED TEAM FUNCTIONS

- 44. To encourage early arrival of teams including holding of training camps in Israel.
- 45. To set aside an afternoon or evening for getting specific teams together.

Session 6. Chairman Roy Salomon

JUNIOR MACCABIAH

RESOLVED on basis of the sub-committee's report.

Sports a. There shall be competition only in individual sports.

- b. Age groups for all competitions to be for those born on or after July 1, 1970. There shall be no minimum age group.
- c. After considering all of the individual sports, the committee agreed and it was resolved that competions should be held in the following:

 GYMNASTICS, SWIMMING, TABLE TENNIS, TRACK & FIELD, TENNIS.
- d. No-one may compete in both Junior and regular events.

Time & Place of Competitions

Where possible we recommend that Junior events be held at the same place and general time as the regular competitions (Maccabiah regular Track & Field events may commence at 20.00 and Junior events could begin at 18.00).

Advantages: a. Gives young athletes a feeling of serious competition in front of a crowd.

- b. Same officials could be utilised for both events.
- c. It would allow Junior athletes to see older and more experienced athletes in competition.
- d. Would increase the crowd for regular events due to the attendance of relatives and friends of Junior athletes.

Note: Junior events should be listed in the Official Programme.

Accommodation

It was una imously agreed that the Junior athletes should be housed together and be as close to the center of all activities as possible. The accommodation center should not be outside the Tel-Aviv area.

Additional findings

- a. As many young Israeli athletes as possible should be housed with the competitors from other countries. The benefit derived will be worth the extra expense.
- b. It must be remembered that there is a two-fold purpose to the Junior Maccabiah, we want to bring young people from the Diaspora to Israel and, we want to encourage and help develop athletes for future Maccabiot. All officials must keep this in mind when choosing their teams,
- c. Athletes will be doing a great deal of touring and hopefully will have competitions at the various kibbutzim after their regular competitions are over.
- d. The Junior Maccabiah will stimulate sports development programmes in the schools, the J.C.C.'s and Maccabi Clubs in the Diaspora. It will encourage a striving for excellence.

e. Potential Junior Maccabiah athletes will be able to compare their performance to those of athletes from other countries through the correspondence competition system introduced by Fred Oberlander. Results from Hanukah events, etc., will be tabulated in Israel and distributed to other countries.

These Junior athletes are our future and we must endeavour to make this experience in Israel a most memorable one. They will be the ones to encourage the young people from their respective countries to visit Israel and possibly compete in future Junior Maccabiot and Maccabiot.

CHARTER OF THE I.M.G.C.

PREAMBLE:

1. The Maccabi World Union (M.W.U.) the progenitor and founder of the Maccabiah Games shall set up a permanent committee for the Maccabiah Games (an I.M.G.C. Executive Board as provided hereunder).

The Maccabiah Games shall be an International Gathering of Jewish amateur sportsmen and women to promote the athletic prowess of the Jewish People, to strengthen the spiritual values of Judaism and to re-inforce the links of the participants with the Old-New Land of Israel.

2. The objects and scope of authority of the I.M.G.C. Executive Board are set out hereunder.

Only the Maccabi World Union (M.W.U.) shall vest authority in the International Maccabiah Games Committee (I.M.G.C.) Executive Board to plan and supervise the Maccabiah Games, held quadrennially in Israel.

3. The responsibility for the financial management of the Games shall be vested in the M.W.U.

SECTION ONE: OBJECTIVES & TERMS OF REFERENCE OF THE I.M.G.C.

- To establish and lay down the general outline and policy governing the Maccabiah Games.
- To encourage and promote the participation of Jewish athletes who are bonafide amateur sportsmen and women of the world in the Maccabiah Games competitions.
- To decide upon the programme of sports events, suitable dates and the duration of the Games, following upon consultation with all countries likely to participate.
- 4. To set up an Organising Committee in Israel (in compliance with Section 3 hereof):
 - a. To instruct the Organising Committee to uphold the rules and regulations governing eligibility, selection and participation in the Games.
 - b. To instruct the Organising Committee to carry out the programming of sporting events and of cultural and recreational activities.

- c. To instruct the Organising Committee to deal with venues, accommodation, transportation and all other matters affecting the welfare of all participants.
- d. To instruct the Organising Committee to include tours of Israel and other activities conforming with the aims and objects of the Maccabi World Movement.
- 5. To set up a Court of Honour consisting of 7 appointed members. The President of the Court to be an Israeli Judge or a member of the legal profession. The composition of members of the Court and its quorum will be determined by the I.M.G.C. Executive Board with due regard to an internationally representative basis. All matters not within the prerogative of the Juries of Appeal (as outlined in Section 3, clause 4 of this document), will fall under the jurisdiction of the Court of Honour, whose decision shall be final and binding. The Court of Honour to be set up by the I.M.G.C. Executive Board.
- 6. To study possibilities of raising the standard of Jewish sport in the world.

SECTION TWO: MEMBERSHIP OF THE I.M.G.C. EXECUTIVE BOARD

- 1. The Chairman of the M.W.U. shall be the Chairman of the I.M.G.C. Executive Board.
- 2. Should the Chairman of the M.W.U. not be available then a majority of all the members of the M.W.U. Executive will elect a Chairman of the I.M.G.C. The M.W.U. Executive shall elect 2 Deputy Chairman on personal merit from the total number of I.M.G.C. members.
- 3. The composition of the I.M.G.C. Executive Board shall be:

President Vice President The Chairman Sport's Authority Maccabi Israel (3) Hapoel (3) Elitzur (1) Betar (1) Europe (5) Australia (2) Canada (2) South Africa (2) Mexico (1) South America (4) U.S. Committee Sports for Israel M.W.U. Executive (3) Chairman Organising Committee Hon. Treasurer.

The Maccabi Norld Union Executive may change such composition if and when required with a majority vote of 2/3rds.

- 4. The Chairman of the I.M.G.C. Executive Board will call for nominations from the Continental Maccabi Constituents as well as from other organisations on a basis to be recommended by the M.W.U. Executive. All nominations will be subject to the approval of the Chairman of the I.M.G.C. Executive Board.
- 5. The I.M.G.C. Executive Board shall be set up not less than 3 years prior to the Games being held, in accordance with the method of nomination set out in Section 2, clause 4. Such Executive Board shall carry on in office untill the appointment of a new I.M.G.C. Executive Board.
- 6. Members of the I.M.G.C. shall be expected to attend all meetings, as convened by the Chairman, after prior consultation with them as to the most convenient date and venue.
- 7. Subject to the I.M.G.C. Chairman's consent and in exceptional cases only, members shall be represented at meetings by duly accredited alternatives of their respective nationalities.
- 8. Every member of the I.M.G.C. shall have one vote. All decisions shall be subject to a simple majority, and in the event of parity, the Chairman shall have a casting vote.
- 9. If, during the interval between meetings of the I.M.G.C., the Chairman has to consult the members, votes can be cast by cable or letter and all decisions so arrived at shall be deemed valid. In the event of a member failing to reply withing the specified time, the Chariman shall be entitled to assume tacit consent.

SECTION THREE THE ORGANISING COMMITTEE (O.C.) IN ISRAEL

1. There shall be set up an O.C. which will submit to the I.M.G.C. Executive Board for its approval, the detailed programming of sporting, Jewish and Israeli culture and touring and all other official events, the respective venues as well as arrangments for feeding, housing, transportation and all other matters relating to the care, health, welfare and safety of the participating teams and their officials throughout their stay in Israel.

On receiving the necessary approval, the O.C. will implement the decisions taken in as efficient a manner as possible and at the same time ensuring that the Games will be consistent with the policy and the acknowledged aims of the Maccabi World Movement.

2. The Chairman of the I.M.G.C. after consulting the Deputy Chairmen, shall appoint a Chairman of the O.C. residing in Israel on the basis of a recommendation from the M.W.U. Executive. This appointment shall be made prior to the first meeting of the I.M.G.C. Executive Board being held.

The Chairman of the O.C. will be an ex-officio member of the I.M.G.C.

- 3. If practical, the Chairman of the O.C. will recommend the members of his Committee for approval at the first meeting of the I.M.G.C. Executive Board. If this is not practical, the proposed members will be submitted to the Chairman of the I.M.G.C. for his approval.
- 4. The O.C. will establish Juries of Appeal for each sport included in the Games and these Juries of Appeal will deal purely with all technical and organisational matters appertaining to their respective sport. Their decisions will be final and binding and not subject to appeal.
- 5. The Chairman of the O.C. shall be in touch with and will report regularly to the Chairman of the I.M.G.C. who in turn will keep members of the I.M.G.C. and the Deputy Chairman fully informed.
- 6. The committee shall consist of as many members as is considered necessary. Heads of Departments of the O.C. shall set up separate sub-committees, entrusted with the implementation of every aspect of planing.
- 7. The set up of the O.C. and its terms of reference and the rules governing the Games shall be subject to approval by the I.M.G.C. It shall invite, enlist and encourage the co-operation of individuals belonging to all Israeli sports organisations and their eligibility shall be decided on competence and personal merit only. Not later than 8 months prior to the opening of the Games, the O.C. will send out its rules and regulations for the competitions to be confirmed by the I.M.G.C. within a period not exceeding one month. Each country will receive these rules and regulations at least 6 months prior to the Games.
- 8. As the financial responsibilities of the Games is that of the M.W.U., the Hon. Treasurer of the M.W.U. shall be a member of the I.M.G.C. as well as act as Treasurer of the Maccabiah Organising Committee in Israel. Should the Hon. Treasurer not be available, the Finance Committee of the M.W.U. Executive will apoint a Treasurer with the same rights and responsibilities as are vested in the Treasurer of the M.W.U.

SECTION FOUR: NATIONAL TERRITORIAL MACCABIAH GAMES ORGANISING COMMITTEE (N.M.G.O.C.)

- 1. In such countries where a Maccabi Territorial Organisation is recognised by and affiliated to the M.W.U., the Territorial Maccabiah Organising Committee shall be set up under its auspices, providing it can satisfy the I.M.G.C. and the M.W.U. with all conditions as set out under Section 4, clause 3.

- f. That it shall include, in addition to its National Insignia, the Maccabiah emblem on uniforms, badges and if possible, also on their flags.
- g. That it shall submit, when applying for participation, a signed declaration to the O.C. that it can satisfy administrative and financial requirements and it shall honour its undertakings.
- h. That it shall assist financially, or in kind, to the best of its ability, the Maccabiah Village project, or any other endeavour designed to enhance the organisational success and prestice of the Games.
- i. That it shall give an undertaking not to use the name Maccabiah for purposes other than herein provided without the consent of the M.W.U.

SECTION FIVE:

In accordance with the decisions of the I.M.C. regarding minimum participation, a set of recommendations have been drawn up to be discussed at the next meeting of the I.M.C.

- 1. Minimum number in each event shall be according to the attached table.
- 2. In case of insufficient numbers of teams in the team event, it has been recommended to allow two Israeli teams to participate or to run the event with three teams and two round-robins.
- 3. In Wrestling and Weightlifiting it is recommended to allow participation of three athletes from each country in each weight category.
- 4. In Track & Field it is recommended to allow participation of four Israeli athletes in case of insufficient numbers of athletes from abroad.
- 5. It is recommended that in the event of only three teams taking part in sports events, only the first prize will be distributed.
- 6. It is recommended that if in the individual events only three athletes from different countries participate, only the first prize will be distributed.

ליאונרד רייפמן (ארה"ב) אמר: "איננו טבורים שהדבר הוא קל ערך. אנו הושמצנו והיינו נתונים לסחטנות. אנו שבאנו להצטרף אל חברינו מארגון בלתי פוליטי הואשמנו כאנשים שאינם דוברי אמת ושאין לתת אמון במניענו. אנו מבקשים שכל אחד באולם זה ובישראל ידע את מניענו. ברצוננו שכל אחד ידע שמטרתנו היא לקדם את תנועת מכבי ולא להכנס עם איש למאבקים פוליטיים".

מיכאל קרוהזי ענה: "ברצוני לחזור על הרגשות אותן הביע דר' פלד ביום הקודם"
"אנו מצטערים על כל מה שקרה. לא רק בגלל שאיננו שמחים לראות אנשים שבמניעיהם

CHARTER OF THE I.M.G.C

PREAMBLE:

- 1. The Maccabi World Union (M.W.U.) the progenitor and founder of the Maccabiah Games shall set up a permanent committee for the Maccabiah Games (n I.M.G.C. Executive Board as provided hereunder).
 - The Maccabiah Games shall be an International Gathering of Jewish amateur sportsmen and women to promote the athletic prowess of the Jewish People, to strengthen the spiritual values of Judaism and to re-inforce the links of the participants with the Old-New Land of Israel.
- 2. The objects and scope of authority of the I.M.G.C. Executive Board are set out hereunder.
 - Only the Maccabi World Union (M.W.U.) shall vest authority in the International Maccabiah Games Committee (I.M.G.C.) Executive Board to plan and supervise the Maccabiah Games, held quadrennially in Israel.
- 3. The responsibility for the financial management of the Games shall be vested in the M.W.U.

SECTION ONE: OBJECTIVES & TERMS OF REFERENCE OF THE I.M.G.C.

- 1. To establish and lay down the general outline and policy governing the Maccabiah Games.
- To encourage and promote the participation of Jewish athletes who are bonefide amateur sportsmen and women of the world in the Maccabiah Games competitions.
- 3. To decide upon the programme of sports events, suitable dates and the duration of the Games, following upon consultation with all countries likely to participate.
- 4. To set up an Organising Committee in Israel (in compliance with Section 3 hereof):
 - a. To instruct the Organising Committee to uphold the rules and regulations governing eligibility, selection and participation in the Games.
 - b. To instruct the Organising Committee to carry out the programming of sporting events and of cultural and recreational activities.

- c. To instruct the Organising Committee to deal with venues, accommodation, transportation and all other matters affecting the welfare of all participants.
- d. To instruct the Organising Committee to include tours of Israel and other activities conforming with the aims and objects of the Maccabi World Movement.
- of the Court to be an Israeli Judge or member of the legal profession.

 The composition of members of the Court and its quorum will be determined by the I.M.G.C. Executive Board with due regard to an internationally representative basis. All matters not within the prerogative of the Juries of Appeal (as outlined in Section 3, clause 4 of this document), will fall under the jurisdiction of the Court of Honour, whose decision shall be final and binding. The Court of Honour to be set up by the I.M.G.C. Executive Board.
- 6. To study ressibilities of raising the standard of Jewish sport in the world.

SECTION TWO: MEMBERSHIP OF THE I.M.G.C. EXECUTIVE BOARD

- 1. The Chairman of the M.W.U. shall be the Chairman of the I.M.G.C. Executive Board.
- 2. Should the Chairman of the M.W.U. not be available then a majority of all the members of the M.W.U. Executive will elect a Chairman of the I.M.G.C. The M.W.U. Executive shall elect 2 Deputy Chairman on reserve erit from the total number of I.M.G.C. members.
- 3. The composition of the I.M.G.C. Executive Board shall be:

President Vice President The Chairman Sports Authority Maccabi Israel (3) Hapoel (3) Elitzur (1) Betar (1) Europe (5) Australia (2) Canada (2) South Africa (2) Mexico (1) South America (4) U.S. Committee Sports for Israel M.W.U. Executive (3) Chairman Organising Committee Hon. Treasurer.

The Maccabi World Union Executive may change such composition if and when required with a majority of 2/3rds.

- 4. The Chairman of the I.M.G.C. Executive Board will call for nominations from the Continental Maccabi Constituents as well as from other organisations on a basis to be recommended by the M.W.U. Executive. All nominations will be subject to the approval of the Chairman of the I.M.G.C. Executive Board.
- 5. The I.M.G.C. Executive Board shall be set up not less than 3 years prior to the Games being held, in accordance with the method of nomination set out in Section 2, clause 4. Such Executive Board shall carry on in office untill the appointment of a new I.M.G.C. Executive B ard.
- 6. Members of the I.M.G.C. shall be expected to attend all meetings, as convened by the Chairman, after prior consultation with them as to the most convenient date and venue.
- 7. Subject to the I.M.G.C. Chairman's consent and in exceptional cases only, members shall be represented at meetings by duly accredited alternatives of their respective nationalities.
- 8. Every member of the I.M.G.C. shall have one vote. All decisions shall be subject to a simple majority, and in the event of parity, the Chairman shall have a casting vote.
- 9. If, during the interval between meetings of the I.M.G.C., the Chairman has to consult the members, votes can be cast by cable or letter and all decisions so arrived at shall be deemed valid. In the event of a member failing to reply within the specified time, the Chairman shall be entitled to assume tacit consent.

SECTION THREE: THE ORGANISING COMMITTEE (O.C.) IN ISRAEL

- 1. There shall be set up an O.C. which will submit to the I.M.G.C. Executive Board for its approval, the detailed programming of sporting, Jewish and Israeli culture and touring and all other official events, the respective venues as well as arrangements for feeding, housing, transportation and all other matters relating to the care, health, welfare and safety of the participating teams and their officials throughout their stay in Israel.
 - On receiving the necessary approval, the O.C. will implement the decisions taken in as efficient a manner as possible and at the same time ensuring that the Games will be consistent with the policy and the acknowledged aims of the Maccabi World Movement.
- 2. The Chairman of the I.M.G.C. after consulting the Deputy Chairmen, shall appoint a Chairman of the O.C. residing in Israel on the basis of a recommendation from the M.W.U. Executive. This appointment shall be made prior to the first meeting of the I.M.G.C. Executive Board being held.

The Chairman of the O.C. will be an ex-officio member of the I.M.G.C.

- 3. If practical, the Chairman of the O.C. will recommend the members of his Committee for approval at the first meeting of the I.M.G.C. Executive Board. If this is not practical, the proposed members will be submitted to the Chairman of the I.M.G.C. for his approval.
- 4. The O.C. will establish Juries of Appeal for each sport included in the Games and these Juries of Appeal will deal purely with all technical and organisational matters appertaining to their respective sport. Their decisions will be final and binding and not subject to appeal.
- 5. The Chairman of the O.C. shall be in touch with and will report regularly to the Chairman of the I.M.G.C. who in turn will keep members of the I.M.G.C. and the Deputy Chairman fully informed.
- 6. The committee shall consist of as many members as is considered necessary. Heads of Departments of the O.C. shall set up separate sub-committees, entrusted with the implementation of every aspect of planning.
- 7. The set up of the O.C. and its terms of reference and the rules governing the Games shall be subject to approval by the I.M.G.C. It shall invite, enlist and encourage the co-operation of individuals belonging to al Israeli sports organisations and their eligibility shall be decided on competence and personal merit only. Not later than 8 months prior to the opening of the Games, the O.C. will send out its rules and regulations for the competitions to be confirmed by the I.M.G.C. within a period not exceeding one month. Each country will receive these rules and regulations at least 6 months prior to the Games.
- 8. As the financial responsibilities of the Games is that of the M.W.U., the Hon. Treasurer of the M.W.U. shall be a member of the I.M.G.C. as well as act as Treasurer of the Maccabiah Organising Committee in Israel. Should the Hon. Treasurer not be available, the Finance Committee of the M.W.U. Executive will appoint a Treasurer with the same rights and responsibilities as are vested in the Treasurer of the M.W.U.

SECTION FOUR: NATIONAL TERRITORIAL MACCABIAH GAMES ORGANISING COMMITTEE (N.M.G.O.C.)

- 1. In such countries where a Maccabi Territorial Organisation is recognised by and affiliated to the M.W.U., the Territorial Maccabiah Organising Committee shall be set up under its auspices, providing it can satisfy the I.M.G.C. and the M.W.U. with all conditions as set out under Section 4, clause 3.
- 2. In each case where these circumstances as in (1) do not apply, the National Territorial Maccabiah Games Organising Committee (N.M.G.O.C.) will be set up with the approval of the I.M.G.C. Executive Board.
- 3. Every N.M.G.O.C. shall be deemed to be duly authorised implementing agency of the O.C. providing it complies with the following conditions:

- a. That it is non-partisan and non-political.
- b. That it shall invite and afford an opportunity to participate in the Maccabiah Games to any eligible Jewish amateur athlete and sportsman in that country, regardless of club affiliation.
- c. That it is representative, as far as possible, of persons familiar with the branches of sport in which the country expects to compete as well as being capable of prestical administration and fund-raising.
- d. In addition to denoting its country, it shall include in its title the words "Maccabiah Organising Committee" translated into the respective languages.
- e. That it shall submit, as soon as is required, a written declaration, made in good faith, of its intentions and ability to send a team of bona-fide Jewish amateur competitors to the Maccabiah Games and to abide by the general rules and regulations as shall govern their selection and participation.
- f. That it shall include, in addition to its National Insignia, the Maccabiah emblem on uniforms, badges and if possible, also on their flags.
- g. That it shall submit, when applying for participation, a signed declaration to the O.C. that it can satisfy administrative and financial requirements and it shall honour its undertakings.
- h. That it shall assist financially, or in kind, to the best of its ability, the Maccabiah Village project, or any other endeavour designed to enhance the organisational success and prestige of the Games.
- i. That it shall give an undertaking not to use the name Maccabiah for purposes other than herein provided without the consent of the M.W.U.

SECTION FIVE:

This Charter shall be capable of amendment by a 2/3rds majority of those entitled to vote at a Congress of the Maccabi World Union.
