Maccabean League of W.A. (Inc.)

CONSTITUTION

(AMENDED 1967)

- 1. The Name of the League shall be "The Maccabean League of W.A."
- 2. The aims and objects of the League shall be to acquire land for the purpose of establishing, developing and maintaining a Memorial Park and Buildings dedicated to the Jewish Servicemen of the State of Western Australia who lost their lives in the 1914-1918 and 1939-1945 World Wars, to uphold traditional Judaism, to promote the unity of the Jewish community in W.A. by cultural, philanthropic, zionist and sporting activities, and to promote the welfare of Jewish Youth, provided that no member shall receive pecuniary profit from the transactions of the League, and provided further that this shall not prevent the employment of a member as a bona fide servant of the League.

- 3. The League shall consist of the following constituent bodies, subject to their compliance with the provisions of this constitution:—
 - (a) The Maccabean Soccer Club.
 - (b) " Cricket Club.
 - (c) " Badminton Club.
 - (d) " Table Tennis Club.
 - (e) " Debating Club.
 - (f) " Men's Basketball Club.
 - (g) " " Ladies' Basketball Club.
 - (h) " Zionist Youth League.

 Such other bodies that are approved as constituent bodies by two thirds majority of the Council.

and

The Direct Members of the League.

- 4. The League shall be governed by a Council consisting of the Executive of the League and two Delegates elected by the members of each constituent body.
- 5. The members of the executive shall be, a President, one Vice-President, one Treasurer, one Secretary, one Assistant Secretary, one Grounds and Building Manager, Immediate Past President, one Vice-President to the Australian Maccabi Council, Hall

Manager, Social Organiser, Maccabean Paper Manager, Finance Organiser and four General Representatives.

- 6 (a) The Executive of the League shall be elected by the members of the League, but any vacancies occurring from time to time on the Executive or in the event of the Executive being increased, the vacancy or new position created, may be filled by a person elected by the Council.
- 6 (b) Nominations for Executive Officers of the League shall be lodged in writing and in the hands of the Secretary fourteen days prior to the Annual General Meeting and shall be signed by the nominated, the proposer and seconder, all of whom shall be members of the League. Should nominations not be received for any of the positions then the Chairman shall accept nominations for those positions at the Annual General Meeting.
 - 7. (a) Membership of the League shall consist of:
 - Family units consisting of parents and unmarried children under the age of 21.
 - Dependant children of a member over the age of 21.
 - Unmarried persons under the age of 21 not covered by sub-section 1.
- 7. (b) Membership of affiliated sections to be restricted to members of the League.

- 8. Membership to the League shall be—In the case of;
 - 7. (a) 1. \$7.00.
 - 7. (a) 2. \$2.50.
 - 7. (a) 3. \$2.50.

or such other amounts as the council may from time to time determine.

- Membership of the Constituent bodies and direct membership of the League shall be open to Jews and Jewesses only.
- 10. The property of the League shall, until incorporation, be vested in three Trustees who shall be appointed and may be removed by the Council.
- 11. Subject to the terms of this Constitution the Council shall be the supreme legislative body in the League and may enact such "Statutes" or take such action as it thinks fit for the progress and good government of the League.
- 12. Without in any way restricting the generality of the foregoing and in addition to any other powers expressly or impliedly by this Constitution conferred upon the Council the Council's power shall include power to enact Statutes with respect to:—
 - (a) Meetings in and out of the League.
 - (b) The proceedings of the Council.

- (d) The infliction of penalties including the penalty of expulsion, for breaches of the Statutes of the Council.
- (e) The delegation of any of the powers of the Council.
- (f) The definition of the duties of the members of the Executive.
- (g) The control and management of the Executive and the disposition of the finances and funds of the League.
- (h) The payment of subscriptions or levies by members of the League or Constituent bodies of the League.
- (i) The management and control of the League.
- (j) The appointment of substitute or "Deputy" delegates to act on the Council in place of absent Delegates.
- (k) The relations between the League and other Jewish and non-Jewish bodies.
- The qualifications required by intending members of the League or candidates for any position in the League.
- (m) The enrolment and resignation of members of the League.

- (n) The control and provision of facilities and benefits for the Direct members of the League.
- (o) Generally for the provision of advancing the objects of the League for doing anything incidental to the above power or the exercise thereof.
- (p) The control of the Maccabean Paper.
- 13. All members of the Executive shall be elected at an Annual General Meeting, the period between such Annual General Meetings shall not be less than 12 months or more than 15 months.
- 14. The Accounts of the League shall be audited and certified by one Auditor appointed by the Annual General Meeting.
- 15. The President of the League and the Presidents of all constituent bodies within the League may call all meetings of and within the League of such bodies at their discretion, and the President of the League shall have a right of access to all meetings thereof.
- 16. Half of the members of the Council or of any Committee in the League shall constitute a Quorum.
- 17. Any member of the Council or of any Committee of the League missing four successive meetings thereof, as the case may be without adequate reason, forfeits his place on such Council or Committee.
- 18. The Council shall meet at least once in each two calendar months.

19. In all cases the power conferred on any body in accordance with the Constitution of the League or the Constitution of any Constituent body of the League, in the absence of any express direction to the contrary, may be exercised by a simple majority of the members of that body present at a duly convened and conducted meeting thereof, or casting their votes where provision is made thereat and without the necessity for the attendance at a meeting.

20. The disposal, by sale, lease, gift or otherwise, of land or buildings of the League or acquisition, leasing or otherwise of further land or buildings by the League, shall be subject to the decision of the majority of members at a Council Meeting and confirmed by 2/3rds majority of members present and voting at an Annual or Special Meeting of Members.

21. (a) At least two (2) weeks' written notice of an Annual General Meeting or any Special General Meeting of the League to be given to Members. A "Notice" inserted in the 'Maccabean' paper prior to the Meeting, providing the Paper is distributed at least (2) weeks before such Meeting, would be sufficient notice to all members.

21. (b) Any notice of motion to be presented to any Annual General Meeting or Special General Meeting of Members must be included in the Notice of Meeting.

22. This Constitution may be amended or added to by (a) the adoption of a resolution proposed by the

Council by a majority of the members of the League voting thereon or (b) the adoption by a majority of the members of the League voting thereon of a resolution proposed by any Constituent body in the League.

23. Subject to the approval or veto of either the Council or the Members of the League, any constituent body may amend or add to its Constitution by the adoption of a resolution proposing the same by a majority of its members.

24. Every Constituent body shall submit a copy of its proposed constitution for approval by the Council.

25. In the event of the League being wound up, the property remaining to the League shall be transferred by way of gift to the Perth Hebrew Congregation, Inc.

26. The League shall have and use a Common Seal (with power to break, alter and change the same from time to time) on which shall be inscribed the name of the League.

The Common Seal shall be kept by the Secretary of the League. The Seal of the League shall not be affixed to any instrument except by the authority of a resolution of the Council and in the presence of the President and Secretary or such other person or persons as the Council may appoint for the purpose; and such President and Secretary or other person or persons as aforesaid shall sign every instrument to which the Seal of the League is so affixed in their presence.
